From the Principal - Lisa Bell

First and most importantly I want to extend my appreciation to each and everyone of you for all of your hard work and support during my first year. I can't tell you how thankful I am for all of your help during my transition to St. Helen School.

I am very excited to be at SHCS, and I love living in Vero Beach! Accepting any position in leadership always comes with the understanding that there is a possibility that tough decisions need to be made.

Our Catholic schools are a vital part of the teaching mission of the Church. We must respond to challenging times with faith, vision and the will to succeed because the Catholic school's mission is essential to the future of our youth, our nation and especially our Church.

First and foremost, I have a fiscal responsibility to be a good steward of our school resources and set realistic budgets. When reviewing the 2018-2019 school budget, which was completed prior to my arrival it was determined, based on projected enrollment, there would be a budget shortfall for the 2019-2020.

A Feasibility Study was conducted by the School Advisory Council and took place in August 2018. The primary purpose of conducting this study was to review the sustainability of continuing a two-class model for the 2019-2020 school year and thereafter.

The findings of the study concluded that there are not enough classrooms to accommodate what is needed under the existing program. The findings further concluded that there was a running year to year budget shortfall primarily because enrollment and revenue did not cover the operational costs of the school.

Based on these findings the decision was made to systematically begin the process of rolling back our classes from the two-class model to one class per grade level.

This is often the hardest part of my job as it requires a non-emotional approach to decisions based primarily on analytical data. St. Helen Catholic School continues to build on the strengths of an already impressive Catholic school. These decisions will ensure that St. Helen Catholic School can continue its mission of Making Good Things Happen for years to come. Thank you for your continued support and prayers.




Financial Report
