- Registered Catholic families who meet the requirements of the Parish Participation Program will receive the subsidized tuition discount of \$1,000 upon receipt of approved Parish Affiliation/Family Acknowledgement form from St. Helen Church, or any Catholic Church within the Diocese of Palm Beach. Catholics outside the Diocese of Palm Beach area, please call and speak with the Business Manager. Parish Participation forms are due to your parish office no later than April 1<sup>st</sup>. No late forms will be accepted.
- New Student Enrollment begins January 17, 2024
- Re-Enrollment for current students begins February 1, 2024
- All families will be required to set up a FACTS account. All payments will be made through FACTS.
- Payment plans for tuition begin July 15<sup>th</sup>.
  - Option 1: Pay in FULL in one payment and satisfy the 20-service hour commitment.
  - Option 2: Pay in two installments due July 15<sup>th</sup> and January 15<sup>th</sup> .
  - Option 3: Payments made in 10 monthly payments on the 15<sup>th</sup> of every month.
- Scholarships for siblings will be available for Catholic families who receive the subsidy discount by participating in the Parish Participation Program. \$500 per sibling will be given starting with the 2<sup>nd</sup> child.

<b>Commitment Fee</b> This fee secures your child’s placement for the 2024-2025 School Year.	\$200	Due by March 1, 2024 per student
<b>Late Fee</b>	\$300	For any commitment form completed after March 1st. Placement will not be guaranteed due to a waitlist.
<b>Registration Fee</b> Fee includes but is not limited to student insurance, textbooks, and technology apps.	\$300	Due July 15 <sup>th</sup> This will be deducted on July 15 <sup>th</sup> through FACTS. This will be in addition to the tuition payment due on the same date.
<b>New Student Fees</b> Application Fee New Student Enrollment Fee	\$200 \$600	The application fee is due when the application is submitted. The new student enrollment fee will be due in order to finalize your enrollment packet. .
<b>International Student Registration Fee</b>	\$600	Due July 15 <sup>th</sup> This covers the cost associated with the F1 Visa.
<b>Graduation Fee</b>	\$150	Per graduating 8 <sup>th</sup> grade student This fee will be deducted on August 12 <sup>th</sup> .
<b>Home and School Fee (HSA)</b>	\$25	Per student- This fee will be deducted on August 12 <sup>th</sup> .
<b>Sports Fee</b>	\$100	Per sport- Athlete will be billed on the date of first practice.
