- We require a signed Continuous Enrollment agreement (once-and-for-all process). This agreement will guarantee a seat for your child until graduation.
- Payment in FULL for tuition and fees by July 15th will satisfy 20 service hours commitment.
- ALL families will be required to set up a FACTS account during the enrollment process.

Registration Fee	 \$ 700 per child per year due in full at time of registration (new students) and automatically withdrawn in FACTS for current students in two installments on March 15 and April 15 each year. > Fee includes but is not limited to student insurance, textbooks, and technology.

Payment Options

St. Helen Catholic School offers the following payment options:

- Option 1 Full payment of tuition, directly to the school, by July 15, 2023
- Option 2 Two payment plan, directly to the school 50% due July 15, 2023, 50% due January 13, 2024
- Option 3 Monthly payment plan only available with FACTS/Tuition Management System
 - A) 10 month plan July 2023 April 2024
 - 1) payment on the 5^{th} or 20^{th} of each month
 - 2) payment on the 5^{th} and 20^{th} of each month
 - B) 11 month plan July 2023 May 2024
 - 1) payment on the 5^{th} or 20^{th} of each month
 - 2) payment on the 5^{th} and 20^{th} of each month
 - C) 12 month plan July 2023 June 2024
 - 1) payment on the $5^{\text{th}} \text{ or } 20^{\text{th}}$ of each month
 - 2) payment on the 5^{th} and 20^{th} of each month
